General Requirements

Guidelines:

- Contractor must only use UL or FM approved equipment/materials. Locally purchased materials must be approved by the COR.
- Lined items may be added or deleted from the attached list after the CO approval. Contractor can only deliver those items approved by the contracting officer (CO).

Superintendence by contractor:

- The entire operation of the contracted services shall be superintended by the contractor's liaison. The liaison shall coordinate the performance of the contracted services with the needs of the USG.

Inspection by government:

- All items furnished under this contract will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all items meet USG requirements, and that all supplies are of acceptable quality and standards.
- The Contractor shall be responsible for any corrective action, within the scope of this contract, which may be required by the Contracting Officer because of such inspection.

A. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract.
